### AGREEMENT, WAIVER, & RELEASE

In consideration for being permitted by Auburn Area Parks and Recreation District (ARD) to participate in the above activity, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter accrue to me as a result of participation in said activity. This release is intended to discharge in advance ARD (its officers, employees, the Amateur Athletic Union of the United States, the National AAU Boy's and Girl's Basketball Committees, and the Auburn Recreation District Youth Development League, and agents) from any and all liability arising out of or connected in any way with my participation in said activity, though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above. It is understood that this activity involves an element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver, release, and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above persons or entities free and harmless from any loss. Liability, damage, cost, or expense which they may incur as a result of my death or any injury or property damage that I may sustain while participating in said activity.

I, the undersigned, assume full responsibility for all risk of injury or loss, which may result from my participation in the ARD-YDL season, practices, scrimmages and games. I understand that I should maintain and carry accident medical insurance coverage. I further understand and agree that I will be financially responsible for all charges and fees incurred in the rendering of emergency treatment. I am aware that this is a release of liability and a contract between myself and Auburn Area Park and Recreation District and I sign it of my free will. This registration is for the ARD-YDL basketball league only, and does not include any membership to the Amateur Athletic Union. All AAU memberships are the sole responsibility of the applicant. ## Coaches Code of Conduct Commitment Statement

As coach of our team, I will:

1. Attend league coach's meeting and communicate with my area representative any suggestions or problems that I might be experiencing.
2. Spend quality time with my team at practices and games. This includes proper supervision. Encourage a parent to become the team parent and help communicate with team members.
3. Handle administrative duties of the team, i.e.: Filling out score sheet before games, have a completed segment sheet ready before game time, have in my possession player medical release forms at all practices and games, and take care of equipment and uniform needs.
4. Be willing to learn more about the game and how to teach youth the proper and safe way to play.
5. Be responsible for team conduct and safeguarding all equipment, facilities and uniforms.
6. Lead by example, demonstrate to my team and their parents fair play, sportsmanship, respect for other teams and officials. Be a model representative of the ARD-YDL.
7. Do not use inappropriate language, alcohol, drugs or tobacco while in the presence of team members.
8. Keep foremost that the purpose of the league is to provide a safe place for our youth to learn more about basketball, develop teamwork skills, to gain a respect for themselves and others around them while having fun. Strive to win, but understand that winning isn't everything.
9. Coaches bear the greatest burden of responsibility for sportsmanship. Their influence upon the attitudes and behavior of the players, the organization, and the community is unequalled.
10. Coaches must control their players and demand that their players respect the opponent and the officials.
11. Always set a good example for participants and fans to follow.
12. Respect the judgment of contest officials, abide by rules of the event .
13. Treat opposing coaches, participants and fans with respect. Shake hands with officials and opposing coach in public.
14. All forms of communication will be non-abusive. Misleading and false statements are unacceptable.
15. Safety and health have a priority over athletic participation and performance. Knowledge of first aid and CPR are recommended for all personnel involved with the team. Security of the youth is of the utmost importance.
16. Encouragement and positive reinforcement will be the focal point for coaches, athletes and volunteers.
17. Ensure that racial, ethnic, religious, and sexual harassment do not occur on your team.

## QUESTIONNAIRE

### EMPLOYEE OR VOLUNTEER BEING CONSIDERED FOR A POSITION HAVING SUPERVISORY AUTHORITY OVER MINORS

Section 5164 of the Public Resources Code of the State of California prohibits the Auburn Area Recreation & Park District from hiring a person for employment at, or hiring a volunteer to perform services at, any of its parks, playgrounds or recreational centers used for recreational purposes in a position having supervisory or disciplinary authority over any minor, if the person has been convicted of certain crimes under the California Penal Code.
