# 4.1 Cover sheet: Contingency Increase on the CV Park Roof Replacement Project

Board of Directors Special Meeting December 20, 2022

#### The Issue

Shall the Auburn Recreation District Board of Directors authorize an additional 10% of contingency funding for the Christian Valley Park building roof replacement project?

#### Background

The ARD Board of Directors awarded a contract to Clark Roofing for the Christian Valley Park building roof replacement project at the October 27, 2022 board meeting in the amount of \$49,424.89 plus a 5% District controlled contingency of \$2,471.00 for a total of \$51,895.89. Three years ago a core sample of the roof was taken that indicated there was one layer of shingles to be replaced on the roof and all bidders based their pricing on this. Upon starting the roof shingle demolition, it was found that there were two layers of shingles which required additional work. It was determined that the initial core sample was taken on a newer section of roof that covered a new building addition but approximately three-quarters of the roof was older and had the concealed double layer. Pricing from the contractor for this added work is \$5,200 in labor, \$300 additional dump fee plus 15% overhead/profit for a total of \$6,325.00.

#### Recommendation for the Board of Directors

Staff recommends that the Board of Directors authorize and approve an additional 10% contingency of \$4,942.40 to cover this work, bringing the total project contingency to 15% or \$7,413.74.

#### Fiscal Impact

Fiscal impact of the approval of the original contract with Clark Roofing Inc. is \$49,424.89 plus a 5% District controlled contingency of \$2,471.00 for a total of \$51,895.89. Adding 10% contingency brings the total to \$56,838.63. The budget for this project is \$55,000.00.


Michael,


Please see attached photo of the the 2nd layer being removed. The second layer is breaking down into little pieces vs the 1st layer coming off in complete shingles.

At the back addition of the preschool there is only one layer but instead of tying into old roofing they overlayed the complete roof. We are having to remove double the staples and is labor extensive. After 2nd layer is removed we will still have to clean the ground and cover the roof with plastic until we return on Monday due to the precipitation that was on the roof this morning we don't want the building to allow water. This additional layer is going to put us into overtime today when we were expecting a short days work.

If we would have known it was two layers during bid time our tear off number would have been double.

We have 50% chance of rain on Tuesday and have no time to spare to keep this building water tight. Please advise.







We are almost finished up with the removal of 1st layer. I have 8 men working onsite today at a overtime rate of \$162 per hour. If we delegate the first four hour it would be a total of \$5,200.00 in labor plus additional dump fee of \$300.00 and with a 15% overhead and profit we are looking at a total of \$6,325.00.				
Without being able to get on the roof at the time of job walk - this was an unforeseen event.
