#### Auburn Pickleball Club Update for ARD Board of Directors 7/21/25

The Auburn Pickleball Club remains committed to our mission of being pickleball ambassadors for the greater Auburn area—and we are proud to report strong momentum.

#### Membership & Visibility

Our club currently boasts 156 members, and interest continues to grow. Our website receives approximately 1,500 new visitors each month, indicating strong community engagement and ongoing curiosity about this fast-growing sport.

#### Community Engagement & Tournament Play

On June 21 & 22, the South Yuba Club hosted Auburn Pickleball Club for its 2nd annual tournament. We had 96 players (two clubs) and played a total of 192 games. Although we did not take home the trophy, we came within just a few points of winning—a marked improvement over last year. We are already making plans to strengthen our tournament skills for next time.

#### **Indoor Play & Lessons**

Indoor pickleball continues at the Regional Gym on Tuesdays, Thursdays, and Sundays, per the ARD Catalog. Friday mornings are open club times are dedicated to drills and lessons. Many of our players schedule their games using the PlayTime Scheduler app, helping keep things organized and accessible.

#### The Fun Committee

A huge shoutout to our Fun Committee, led by Kim and Amy, who have created a welcoming and upbeat atmosphere that encourages community participation. All events are open to the public, with at least one court always reserved for drop-in play. Highlights include:

- Queen of the Court Tuesdays & Wednesdays (Summer and Winter)
- Women's League Tuesdays (Spring and Fall)
- Mixed League Wednesdays (Spring and Fall)
- Monthly Public Events Drawing ~50 attendees per event

Our next big event, Friday Night Lights: Tropical Tang Pickleball Party, takes place on July 18. It is being described as "a zesty night of pickleball, tropical and sour-themed outfits, juicy jams, and summer vibes." Costumes are encouraged—pineapples, flamingos, lime green, even Sour Patch Kid-inspired looks. Keep in mind that these events are always open to the general public and it's not necessary to be a member of the club.

#### Welcome Committee Launch

Our newest initiative is the Welcome Committee, which provides free lessons and helps integrate brand new players into the local pickleball community. Flyers have been posted at Regional Park, School Park Preserve, and Meadow Vista, and we include lesson details in our weekly emails.

#### The Need for More Courts

School Park Preserve Courts are buzzing with activity. More families are joining in—including my son's family, with kids ages 10, 7, and 6. The interest is real and growing. Simply put: we need more courts to keep up with this fun, fast-growing sport.
