Membership & Visibility

October 2026 will mark the 3rd year of APC. Our club currently has 138 members. Our website receives new visitors each month, indicating strong community engagement and ongoing curiosity about this fast-growing sport.

Community Engagement & Tournament Play

The Auburn Pickleball Club has an Instagram and Facebook page. At our January meeting we planned out events for the year which will be posted on our website.

Indoor Play & Lessons

We are excited to be back playing at Recreation Gym on Tuesdays, Thursdays, Fridays and Sunday. The gym has been packed with players of all levels. We use a whiteboard to keep games competitive and moving along.

Indoor pickleball continues at the Regional Gym on Tuesdays and Fridays. Members have access to the ball machine on those days. All indoor play is scheduled on the PlayTime Scheduler app. You must be a member of the club or purchase a wristband to play indoors.

The Fun Committee

A huge shoutout to our Fun Committee, led by Kim and Amy, who have created a welcoming and upbeat atmosphere that encourages community participation. All events are posted on Playtime scheduler and are open to the public, with at least one court always reserved for drop-in play. Highlights include:

- Queen of the Court – Tuesdays & Wednesdays (Summer and Winter)
- Women's Ladder – Tuesdays (Spring and Fall)
- Mixed Ladder – Wednesdays (Spring and Fall)
- Monthly Public Events – Our next event is February 6th. Details and sign-ups will be posted on the Play time scheduler app.

Welcome Committee

The Welcome Committee provides free lessons and helps integrate brand new players into the local pickleball community. Flyers have been posted at Regional Park, School Park Preserve, and Meadow Vista. Our weekly emails provide information for lessons with a pro.

The Need for More Courts

Open play at Regional park is full of high-level players on Tuesdays, Thursdays, Saturdays, and now Sunday mornings. It is difficult for newer players and families to access the courts.
