Auburn Pickleball Club Update for ARD Board of Directors July 2026

The Auburn Pickleball Club builds health, connection and community through organized play.

The Auburn Pickleball Club is dedicated to promoting healthy, active lifestyles while creating opportunities for meaningful social connection through the sport of pickleball. Our organized programs serve adults of varying ages and skill levels by providing consistent opportunities for physical activity, skill development, and community engagement.

Indoor Play & Lessons

All indoor play is posted on the Playtime Scheduler App. Indoor play includes players of all levels, from beginners to advanced. We have created a welcoming and supportive atmosphere while building confidence and skill on the court. On Fridays, we offer instruction to new players.

Friday Night Lights

Approximately every six weeks, the club hosts **Friday Night Lights**, a themed community event that brings members together for an evening of organized pickleball, social interaction, and fellowship. These events provide an inclusive environment where new and longtime members connect, friendships are strengthened, and community relationships continue to grow. Friday Night Lights has become one of the club's signature programs, helping create a welcoming culture that encourages long-term member participation

Seasonal Leagues

The Auburn Pickleball Club offers organized league play **twice each year**, serving **40-60 participants** during each league season. League play provides structured competition among players of similar skill levels while promoting sportsmanship, personal growth, and regular physical activity. Participants benefit from consistent play, measurable skill improvement, and increased confidence while developing relationships with fellow members. Beyond competition, the leagues encourage accountability, teamwork, and continued engagement within the club, contributing to higher member retention and a stronger sense of community.

Weekly Queens of the Court

Every Tuesday evening, the club hosts Queens of the Court, a women's organized rotation event that attracts 20 participants each week. The rotating partner format encourages interaction among players who might not otherwise have the opportunity to play together, fostering new friendships while creating an inclusive environment that supports both recreational and competitive athletes. The program has become an important source of encouragement, mentorship, and community for women seeking regular physical activity in a supportive setting.

Weekly Kings & Queens of the Court

Each Wednesday evening, the club continues this successful format through Kings & Queens of the Court, a mixed-gender organized rotation program. The event provides another consistent opportunity for members to participate in structured play while strengthening relationships across the club. By rotating partners and opponents throughout the evening, participants experience balanced competition, increased social interaction, and a welcoming atmosphere that reflects the club's commitment to inclusion.

Community Impact

Together, these organized programs create year-round opportunities that extend well beyond recreational sport. They promote:

- Increased physical activity and lifelong fitness.
- Improved mental health through regular social connection and community engagement
- Reduced social isolation by creating welcoming spaces where lasting friendships develop.
- Leadership and volunteer opportunities that strengthen community involvement.
- An inclusive environment where players of varying backgrounds and skill levels feel welcomed and supported.
- Positive community engagement through regularly scheduled events that encourage ongoing participation.
